

In case EMD submitted by Bank Draft through any other branch of nationalise bank, then the realization / service charge of Rs. 200.00 per Rs.20,000/- or part thereof is to be paid extra.

Vehicles which have completed not more than three years from the date of its first registration till the date of issuance of this notice will only be hired. The hiring will be done for a minimum of two year period to a maximum period of Five years period.
